In accordance with the CJR Final Regulation, Participant Hospitals are permitted to partner with providers ("Collaborators") and enter into financial arrangements in which Participant Hospitals may share savings based on the result of care redesign efforts initiated as part of the CJR Model with Collaborators who have signed such financial agreements with Participant Hospitals.

Providers will be required to sign a CJR Collaboration Agreement with Participant Hospitals and adhere to the contents of the agreement in terms of care redesign and quality criteria to be eligible for incentive payments. Incentive payments will be determined based on financial savings achieved under the CJR Model, known as Net Payment Reconciliation Amounts (NPRA). Quality criteria established by the Participant Hospitals will be tied to the methodology in which incentive payments are distributed to Collaborators.
